
Memorandum of Understanding

Between

And

This Memorandum of Understanding (MOU) is starting from 1st April 2023 till 31st March 2024 and sets for the terms and understanding between Young Indians and 11 eleven bakery, Kolkata as mentioned in this MOU.

Introduction of Partners
