# Memorandum of Understanding

Between

(Young Indians)

And

(Garden cafe, Kolkata)

This Memorandum of Understanding (MOU) is starting from 1<sup>st</sup> April 2023 till 31st December 2024 and sets for the terms and understanding between Young Indians and Garden cafe, Kolkata as mentioned in this MOU.

## Introduction of Partners

Young Indians (YI) is an integral part of the Confederation of Indian Industry (CII), a nongovernment, not-for-profit, industry led and industry managed organisation playing a proactive role in India's development process.

YI was formed in the year 2002 with an objective of creating a platform for Young Indians to realize the dream of a developed nation. In the absence of mutual agreement by the authorized officials from (list partners) this MOU shall end 31<sup>st</sup> December 2024

This MOU shall be deemed to have come into force and effect as of the date of signing and shall remain in force till 31<sup>st</sup> December 2024 and may be further renewed by the parties upon mutually agreed terms and conditions.

This MOU is not a legally binding document' and serves only as a guideline of the terms of engagement mutually agreed to between the said partners. The said MOU shall in no form be legally enforceable and has no binding on either party/ partner involved in the same.
