

Memorandum of Understanding

Between

(Young Indians)

And

(The Grid, Kolkata – Unit of Karnani FnB Specialities LLP)

This Memorandum of Understanding (MOU) is starting from 1st April 2023 till 31st March 2024 and sets for the terms and understanding between **Young Indians** and **The Grid**, Kolkata as mentioned in this MOU.

Introduction of Partners

Young Indians (Yi) is an integral part of the Confederation of Indian Industry (CII), a nongovernment, not-for-profit, industry led and industry managed organisation playing a proactive role in India's development process.

Yi was formed in the year 2002 with an objective of creating a platform for Young Indians to realize the dream of a developed nation. This MOU is not a legally binding document' and serves only as a guideline of the terms of engagement mutually agreed to between the said partners. The said MOU shall in no form be legally enforceable and has no binding on either party/ partner involved in the same.
