# Memorandum of Understanding

Between

(Young Indians)

And

IKAIGARI , Kolkata)

This Memorandum of Understanding (MOU) is starting from 1<sup>st</sup> April 2023 till 31st December 2024 and sets for the terms and understanding between Young Indians and IKAIGARI , Kolkata as mentioned in this MOU.

## Introduction of Partners

Young Indians (Yi) is an integral part of the Confederation of Indian Industry (CII), a nongovernment, not-for-profit, industry led and industry managed organisation playing a proactive role in India's development process.



