

# Memorandum of Understanding

This Memorandum of Understanding (MOU) is starting from 1<sup>st</sup> January 2023 and sets for the terms and understanding between Young Indians and KALIGODAM, Kolkata as mentioned in this MOU.

## Introduction of Partners


Terms & Condition
