



Memorandum of Understanding

This Memorandum of Understanding (MOU) is starting from 1st January 2023 and sets for the terms and understanding between Young Indians and Kenilworth Resort, Goa as mentioned in this MOU.

Introduction of Partners

Young Indians (Yi) is an integral part of the Confederation of Indian Industry (Cll), a nongovernment, not-for-profit, industry led and industry managed organisation playing a proactive role in India's development process.

In the absence of mutual agreement by the authorized officials from Kenilworth Resort, Goa, this MOU shall end 31st December 2024.

This MOU shall be deemed to have come into force and effect as of the date of signing and shall remain in force till 31st December 2024 and may be further renewed by the parties upon mutually agreed terms and conditions.

This MOU is not a legally binding document' and serves only as a guideline of the terms of engagement mutually agreed to between the said partners. The said MOU shall in no form be legally enforceable and has no binding on either party/ partner involved in the same.
