



Memorandum of Understanding

This Memorandum of Understanding (MOU) is starting from 1st January 2023 and sets for the terms and understanding between Young Indians and Manik Chand Jewellers as mentioned in this MOU.

Introduction of Partners

Young Indians (Yi) is an integral part of the Confederation of Indian Industry (Cll), a nongovernment, not-for-profit, industry led and industry managed organisation playing a proactive role in India's development process.
