This Memorandum of Understanding (MOU) is starting from 1st April 2023 till 31st December 2024 and sets for the terms and understanding between Young Indians and Unity vincom pvt ltd, Kolkata as mentioned in this MOU.

Introduction of Partners

Young Indians (Yi) is an integral part of the Confederation of Indian Industry (CII), a nongovernment, not-for-profit, industry led and industry managed organisation playing a proactive role in India's development process.
