



Memorandum of Understanding

Between

And

(PARINA Ethnic wear, Kolkata)

This Memorandum of Understanding (MOU) is starting from 1st January 2023 and sets for the terms and understanding between Young Indians and PARINA Ethnic wear, Kolkata as mentioned in this MOU.

Introduction of Partners
