



Memorandum of Understanding

This Memorandum of Understanding (MOU) is starting from 1st April 2023 till 31st December 2023 and sets for the terms and understanding between Young Indians and Pinkk sugars- patisserie and artisanal bakery Kolkata as mentioned in this MOU.

Introduction of Partners
