# Memorandum of Understanding

This Memorandum of Understanding (MOU) is starting from 1<sup>st</sup> April 2023 till 15th April 2024 and sets for the terms and understanding between Young Indians and Pings cafe orient , Kolkata as mentioned in this MOU.

## Introduction of Partners


