

Memorandum of Understanding

Between

(Young Indians)

And

(TABLE TOP TREATS, Kolkata)

This Memorandum of Understanding (MOU) is starting from 1st January 2023 and sets for the terms and understanding between Young Indians and TABLE TOP TREATS Kolkata as mentioned in this MOU.

Introduction of Partners

Young Indians (Yi) is an integral part of the Confederation of Indian Industry (CII), a nongovernment, not-for-profit, industry led and industry managed organisation playing a proactive role in India's development process.

Yi was formed in the year 2002 with an objective of creating a platform for Young Indians to realize the dream of a developed nation. This MOU is not a legally binding document' and serves only as a guideline of the terms of engagement mutually agreed to between the said partners. The said MOU shall in no form be legally enforceable and has no binding on either party/ partner involved in the same.



