

Memorandum of Understanding

Between

(Young Indians)

And

(THE CASTLE DESIGNS, Kolkata)

This Memorandum of Understanding (MOU) is starting from 1st January 2023 and sets for the terms and understanding between Young Indians and THE CASTLE DESIGNS Kolkata as mentioned in this MOU.

Introduction of Partners
