## Memorandum of Understanding

This Memorandum of Understanding (MOU) is starting from 1<sup>st</sup> April 2023 till 31st march 2024 and sets for the terms and understanding between Young Indians and Taj city centre New town , Kolkata as mentioned in this MOU.

### Introduction of Partners
