



# Memorandum of Understanding

Between

And

Zest: The Next Level

This Memorandum of Understanding (MOU) is starting from 1st January 2023 and sets for the terms and understanding between Young Indians and Zest: The Next Level as mentioned in this MOU.

### Introduction of Partners

Young Indians (Yi) is an integral part of the Confederation of Indian Industry (Cll), a nongovernment, notfor-profit, industry led and industry managed organisation playing a proactive role in India's development process.

Yi was formed in the year 2002 with an objective of creating a platform for Young Indians to realize the dream of a developed nation.
