

Memorandum of Understanding

Between

This Memorandum of Understanding (MOU) is starting from **1st January 2023** and sets for the terms and understanding between **Young Indians** and **Aditya Jain Atelier** as mentioned in this MOU.

Introduction of Partners

Young Indians (Yi) is an integral part of the Confederation of Indian Industry (CII), a nongovernment, not-for-profit, industry led and industry managed organisation playing a proactive role in India's development process.

Yi was formed in the year 2002 with an objective of creating a platform for Young Indians to realize the dream of a developed nation.
