

Memorandum of Understanding

Between

(Young Indians)

And

Bipin Jewellers

This Memorandum of Understanding (MOU) is starting from **1st January 2023** and sets for the terms and understanding between **Young Indians** and **Bipin Jewellers** as mentioned in this MOU.

Introduction of Partners

Young Indians (Yi) is an integral part of the Confederation of Indian Industry (CII), a nongovernment, not-for-profit, industry led and industry managed organisation playing a proactive role in India's development process.

Yi was formed in the year 2002 with an objective of creating a platform for Young Indians to realize the dream of a developed nation. Yi has around 2800 direct members in 44 chapters, and engages around 18000 students through the brand 'YUVA'. In the absence of mutual agreement by the authorized officials from **Bipin Jewellers** this MOU shall end **31st December 2024**.

This MOU shall be deemed to have come into force and effect as of the date of signing and shall remain in force till 31st December 2024 and may be further renewed by the parties upon mutually agreed terms and conditions.

This MOU is not a legally binding document' and serves only as a guideline of the terms of engagement mutually agreed to between the said partners. The said MOU shall in no form be legally enforceable and has no binding on either party/ partner involved in the same.
