## Memorandum of Understanding

This Memorandum of Understanding (MOU) is starting from 1<sup>st</sup> august 2023 and sets for the terms and understanding between Young Indians and Advitya by Shreya ,Kolkata as mentioned in this MOU.

### Introduction of Partners
